Save the Date, February 11th, LWV Anniversary Luncheon

Former Phoenix Mayor Paul Johnson will be the featured speaker at our annual anniversary luncheon in Sedona on Saturday, February 11, 2012. Mayor Johnson will provide a history of Arizona's primary election system and discuss how and why it might be changed. (Paul Johnson is chairing a committee that is attempting to put forth a ballot proposition calling for nonpartisan "open primaries" in our state). Our traditional February luncheon fundraiser celebrates the founding of the League of Women Voters on February 14th, 1920, and this year we will be recognizing Arizona's Centennial as well. It will take place at the Agave Event Center adjacent to the Best Western Plus Inn of Sedona at the corner of North Airport Road and S.R. 89A. Cost for the luncheon is tentatively set at \$25.00 (no price increase!) and invitations will be sent out in April.

The national league recently unveiled its new website design at www.lwv.org. This is part of the current emphasis on better, more effective use of new media and technology. According to LWVUS Communications Committee Chair Susan Wilson, the new site has improved search functionality, is more simply organized and does not require login to access most of the content. League Member Assists in Discussion of “Iron Jawed Angels”

On October 26, 2011, board member Liz Danbury moderated a discussion around the film “Iron Jawed Angels,” sponsored by Democrats of the Red Rocks. The film, by Katja von Garnier, chronicles the incredible journey of a group of suffragist activists led by Alice Paul and Lucy Burns as they gave up their personal lives and put themselves in great danger to fight for American women's right to vote. They worked with Carrie Chapman Catt and Anna Howard Shaw, founders of the National American Women Suffrage Association, but wanted to push for a constitutional amendment rather than the state-by-state approach preferred by Catt and Shaw. Their lobbying efforts in Washington, D.C., turned into an epic struggle and brutal imprisonment, but their efforts and those of many others in the suffragist movement eventually resulted in the 19th Amendment to the Constitution of the United States (the “Susan B. Anthony Amendment”) on August 26, 1920. The amendment gave some 20 million women the right to vote.

League members interested in reinforcing their dedication to the work of the League of Women Voters can seek inspiration from the “Iron Jawed Angels.”

Redistricting Update

As most of you know, the redistricting process was stalled by the removal of the chairperson for the Independent Redistricting Commission by the Governor and the Arizona Senate. The removal was taken to court and the chairperson was reinstated. The League of Women Voters Arizona filed an amicus brief against the

actions of the Governor and Legislature in trying to overturn the process of the commission. The commission is back at work completing the process of finalizing the congressional and legislative redistricting maps. The commission hopes to complete finalize the maps by Christmas so that they can go the U.S. Department of Justice for pre-clearance approval.

Yavapai County's redistricting map (Alternate A) has been approved by the Department of Justice.
